

# Inspire Trust Corporate Fixed Income Common Trust Fund



## Investment Objective

The Fund's investment objective is total return, consistent with preservation of capital and prudent investment management. The fund should also generate income commensurate with the current fixed income environment.

## Investment Guidelines and Restrictions

- The fund provides moderate current income by investing in primarily intermediate-maturity investment-grade corporate securities. The fund may also invest in corporate preferred stocks.
- The fund may also invest in high yield corporate bonds, foreign bonds, and in U.S. Treasury, and agency vehicles.
- The fund will emphasize higher-quality, intermediate-term bonds that are selected across sectors and geographies to avoid concentration risk, particularly with respect to credit.

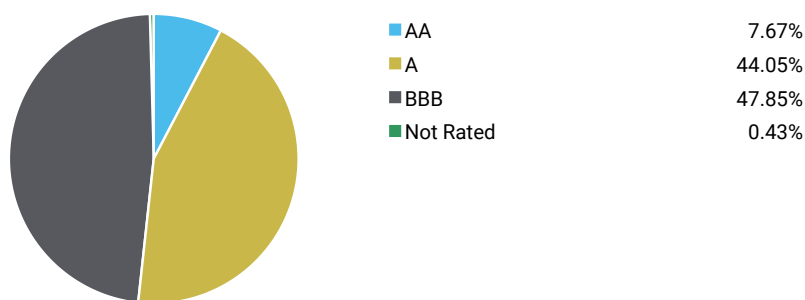

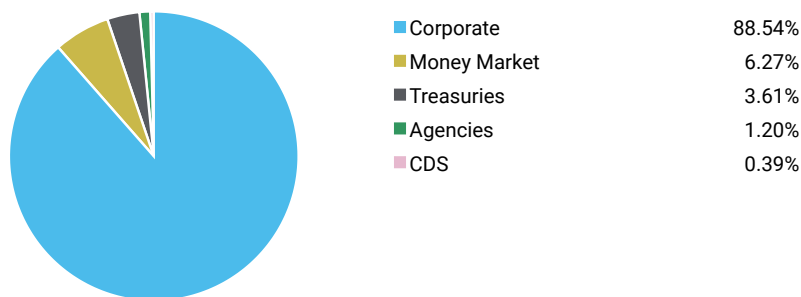
